


#### Where Homelessness Rose in SPA 8 SD 4 from 2016

- Vehicular homelessness went up by 23% (827 to 1018)
- The cities with the largest raw number increases were:
  - ...City of Los Angeles (up by 120 persons)
  - ...City of Redondo Beach (up by 45 persons)
  - ...City of Torrance (up by 39 persons)

## 49% of persons experiencing homelessness in SPA 8 were in SD 4

Including the following SD 4 percentages of SPA 8:

Vehicles: 59%
Street: 53%
Transitional Shelter: 43%
Emergency Shelter: 17%
