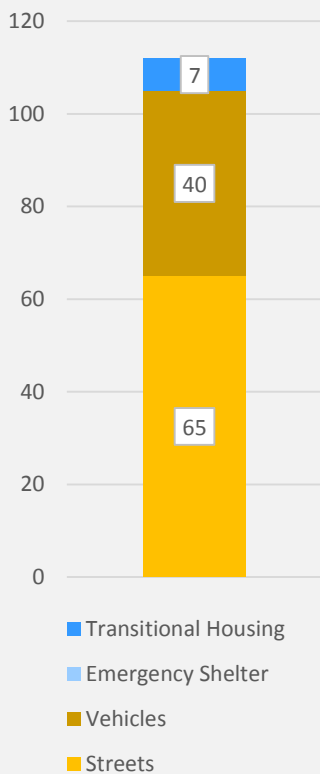




# 2015 Greater Los Angeles Homeless Count

## Persons Experiencing Homelessness by Location

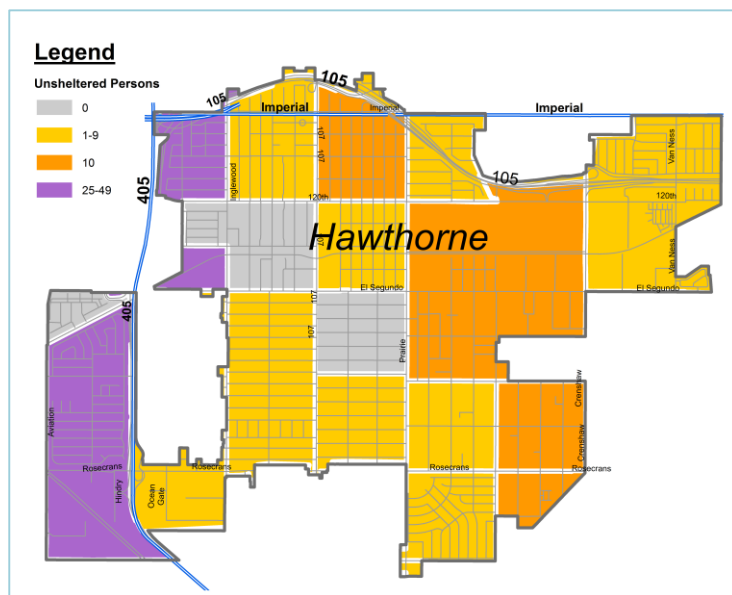

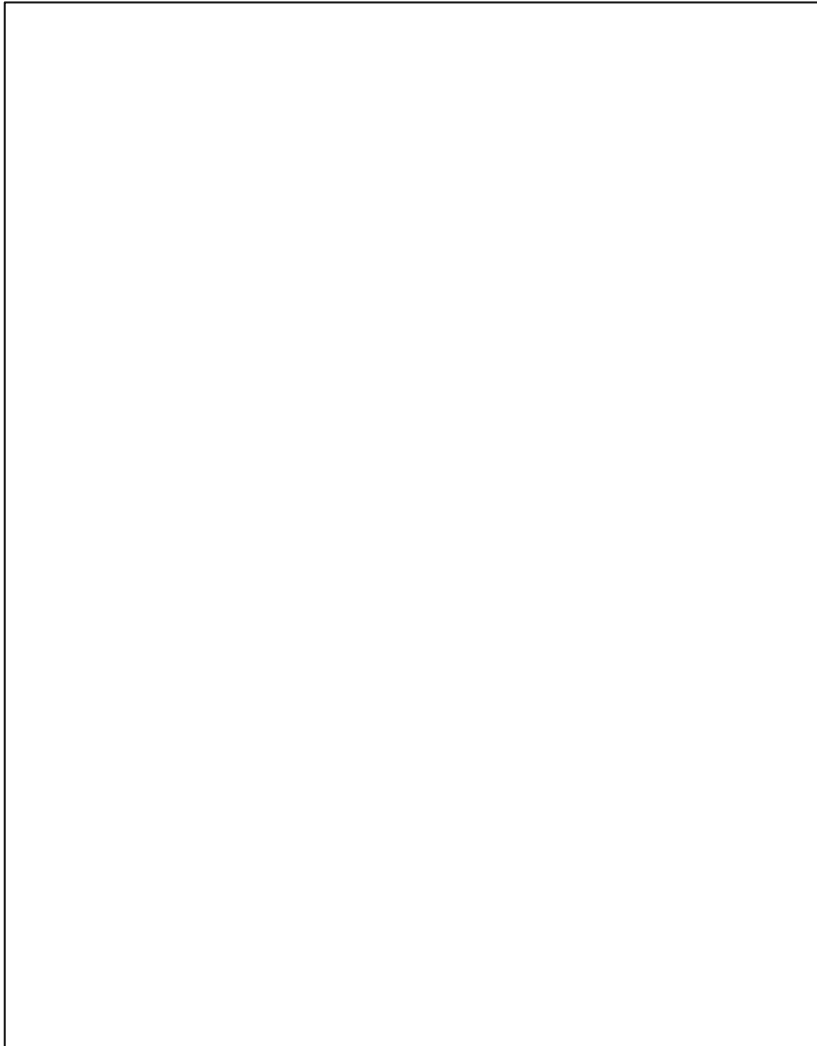
## Hawthorne 112 Homeless Persons on January 28, 2015

- 4% of the South Bay's Unsheltered population is located in Hawthorne (living in vehicles or on the streets)
- There are approximately 13 times more vacant housing units than homeless persons in Hawthorne (Source: CA Department of Finance, "E-5 Population and Housing Estimates for Cities, Counties, and the State, January 2011-2015, with 2010 Benchmark," May 2015).
